Greene County Board of Supervisors met at 8:30 a.m. in the courthouse boardroom with all supervisors present: Bardole, Burkett, Conter, Muir, Rudolph. Motion by Bardole, second by Rudolph to approve the agenda. Motion carried unanimously. Motion by Burkett, second by Bardole to approve the minutes of June 5, 2017. Motion carried unanimously.

Supervisor Dawn Rudolph reported that the Board of Health and the supervisors plan to hold a joint meeting for more conversation regarding public health services and the future of that collaboration in the county. The meeting is scheduled for Tuesday, July 11th from 8 – 10:00 a.m. at the GCMC board room. Rudolph additionally reported on an animal shelter meeting and discussion.

Jefferson city administrator Mike Palmer reported the status of the city's various public improvement projects. Chair John Muir brought up the topic of the new city/county impound lot and the need to discuss the division of those additional costs incurred (for fencing and rock) between the two entities.

Motion by Rudolph, second by Burkett to accept the Recorder's Report of Fees for May. Motion carried unanimously. Motion by Bardole, second by Rudolph to accept the Treasurer's Investment & Driver's License Report for May. Motion carried unanimously.
